

ROUTE TO QUALIFICATION



SOLICITOR APPRENTICESHIP

Law is an exciting career prospect for many, but university isn't always the right choice for every person.

Our Solicitor Apprenticeship programme offers aspiring solicitors an alternative path into the legal profession. You will earn while you learn, gaining valuable experience from day one with no university fees to pay.

It's a great alternative to studying full-time at university if you wish to pursue a career in law without having to take out a student loan. You'll earn your qualification through a combination of work and part-time study over a period of up to six years, and at the end of the program, you'll have the same level of qualification as trainee solicitors who qualify through the traditional University route. It combines practical experience in the workplace with a formal degree and postgraduate study. You'll go to work and receive a full-time salary and get valuable, real-life experience in your chosen field while you earn a degree at the same time.

Details of the Program

As an apprentice, you will gain the professional solicitor qualification that will demonstrate your commercial legal ability, client service experience, ethical behaviour and commitment to lifelong learning and development. Studying under BPP, the education provider we have chosen to work with, you will develop your teamwork, presenting and time-management skills and earn an LLB (Hons) Legal Practice qualification.

This 72-month programme consists of 20 modules studied over the duration of the course. During the first four years, apprentices will focus on the foundational principles of law and develop their



professional skills. In the final two years they will develop their knowledge of different areas of legal practice alongside professional skills while preparing to sit the Solicitors Qualifying Examination.

To complete the apprenticeship, you must pass the Solicitors Regulation Authority centralised assessment, which consists of a range of assessments and the compilation of a portfolio of your work experience.

SQE1: Functioning Knowledge Tests and SQE2: Standardised Practical Legal Skills Assessments. BPP will provide you with guidance and assistance to help you pass these assessments.

Qualifications required

- Be predicted to obtain or have gained 3 or more A levels at grade B or above or acceptable alternatives e.g. completion of the Paralegal Level 3 apprenticeship (or similar vocations apprenticeship, or a BTEC Level 3 Extended Diploma (formally BTEC National Diploma).
- Five GCSEs at grade C (or 4) or above, including English and Mathematics (or equivalent)
- Reside within easy travelling distance of at least one of our offices in Leeds City Centre, Pudsey, Yeadon or Bradford.

GRADUATE ENTRY SOLICITOR APPRENTICESHIP



Our graduate solicitor apprenticeship will support you through the new pathway to qualification by completion of the Solicitors Qualifying Exams (SQE1 and SQE2) which replaced the Legal Practice Course (LPC) in September 2021. This means that you can join us straight from your

degree or GDL and start gaining on the job experience, and earning a salary, earlier.

Details of the Program

This 30-month programme consists of five legal practice modules studied over 20 months, with the remainder of the programme focusing on professional practice skills coursework, preparation and sitting the End Point Assessment (SQE1 and SQE2).

You will complete work placements across different areas of the business, learning from

leading experts in the legal field. In total, 20% of the apprenticeship will be spent doing off-the-job training. A day each week will be dedicated to off-the-job study, with the four remaining days focused on the required work-based experience across placements.



At the end of the programme, you will sit the Solicitors Qualifying Examination assessments.

Qualifications required

- UK bachelors degree in any subject at 2.1 or above or equivalent
- Five GCSEs at grade C (or 4) or above, including English and Mathematics (or equivalent)
- Reside within easy travelling distance of at least one of our offices in Leeds City Centre, Pudsey, Yeadon or Bradford.
